Welcome and Charge to the Panel:

The Honorable Beth Bye, Commissioner, Connecticut Office of Early Childhood called the meeting to order and introduced The Honorable Ned Lamont Governor of Connecticut.

Governor Lamont welcomed and thanked the Blue Ribbon Panel members. He shared his vision and charge:

 Highlighting the importance of child care - to give the very best opportunity for a child to start a life.



- Spoke to the panel's charge to connect with experts and come up with innovative ways to maximize dollars to have the greatest impact for children.
- The charge is to take care of more children in a more effective and affordable way throughout the state of Connecticut.
- Spoke to the need for various stakeholders to take part in the solution; i.e. corporate community.
- Goal is to make Connecticut the most family-friendly state in the nation.

Introductions, Committee Roles, and Timeline:

Commissioner Bye introduced Dan Wuori, Senior Director of Early Learning at The Hunt Institute.

Dan Wuori led a roundtable introduction of Blue Ribbon panelists before giving a high-level understanding of Hunt Institute's role. The Hunt Institute supports educational policy and serves as a resource to the nation's leaders.

Leading for Young Children:

Commissioner Bye introduced Dr. Valora Washington, Founder and CEO, CAYL Institute.

Dr. Washington presented CT: Architects of Change for the Next Generation of Children, Families, and Early Childhood Educators

- Dr. Washington spoke to the importance of child development and the historical shift that has happened over the past 40 years, related to what we understand about child development. Now we have data that shows that the birth to five years shape the rest of a child's life, and we need to act on this knowledge.
- Presentation touched on key guidelines for the panel members to do this work:
 - Persist Focus on adaptive work
 - o Reform Think about sustainable innovations
 - O Transform Think about sustainable funding beyond COVID dollars
 - O Reframe Change the narrative around child care
- Focus areas should include: Equity, Workforce, Systems, Financing
- Left the panel with the vision to develop a new solution: "System is broken across the nation.
 Can't go back to normal normal never worked for us." "There is no preexisting answer we need to create the answer."

Building a World Class System for Connecticut Families: Perspective and Lessons from Across the Nation:

Commissioner Bye introduced Dr. Dan Wuori, Senior Director of Early Learning, The Hunt Institute, and Dr. Cynthia Osborne, Founder and Executive Director, Prenatal-to-3 Policy Impact Center.

Dr. Wuori and Dr. Osborne shared their expert advice with the panel and led a roundtable discussion with Blue Ribbon panelists.

- Current child care policy is based on the myth that learning begins in kindergarten and child care is simply a warm custodial place where kids are safe while parents work.
- Shared details on brain science and connections starting in a child's first years. Importance of child care as the most important learning environment for children.
- CT is the 5th most expensive state in the nation for child care.
- Shared national child care field data turnover in field is 40% per year. Teachers are making \$13.22 an hour nationally.
- Dr. Wuori referenced a ReadyNation report on the lack of access to infants and toddlers creating a \$1.5 billion impact in CT. This fiscal impact is on parents in lost or forgone wages, employers in workforce challenges, and taxpayers in economic impact.

Commissioner Bye and Deputy Commissioner Trueworthy presented Landscape of CT Early Childhood Education System

Areas of Focus included:

- Early Childhood Education in Connecticut (ecosystem)
 - Challenges in Connecticut's early childhood education space
 - O Connecticut's numerous, complex sources of funding for early childhood education
 - O CT state-funded early childhood education programs



- State, federal, & jointly funded early childhood education
- Historical view of child care capacity in CT from 2013 2023
- O Center-based child care ratios in US, CT and NAEYC Accreditation Standards
- Parent survey results
- CT's ECE costs compared to other high cost-of-living states
- Despite infant/toddler costs being more expensive pre-k costs, pre-k receives more funding
- Range in estimates for true parent demand for formal care for infants and toddlers
- Market rate funding flows
- O UConn cost of care analysis vs current registry salaries, personnel costs
- Enrollment in regard to system stability
- O Blue Ribbon Planning will estimate the costs and impacts of a range of potential strategies to address system wide issues and opportunities
