Indicates that information is collected only for caregivers who enrolled prenatally or within 30 days after delivery. For depression and IPV screening, for caregivers who did not enroll prenatally, please follow the schedule in “Timing of Home Visiting Measures by Enrollment and Quarter”.

\* The instrument that is used to assess Parent-Child Interaction is model-dependent. Some programs use the Piccolo which begins at 10 months; some use the HOME or the Dance which begin at 1 month, and some use the CHEERS Check-in. The Cheers Check-in can be used with children as young as 4 months. However, for benchmark purposes, the Cheers Check-in is not expected until the child turns 6 months old. Once the child turns 6 months old, they will be included in the Parent-Child Interaction measure. For programs who use the PICOLLO or HOME/DANCE, children will be included once they turn 10 months or 1 month old, respectively.

\*\* Note that the schedules for well-child visits, ASQ, and ASQ-SE each go beyond 30 months. The full schedules, with timing windows, are shown below.

The OEC home visiting program requires information to be collected throughout the course of a family's enrollment. This table shows the timing of the data collection as it lines up with the child's age. Other measures are aligned more with a caregiver's length of enrollment, and/or calendar year. The table that shows those measures is “Timing of Home Visiting Measures by Enrollment and Quarter”. Please use both tables together; together they cover the timing for all data collection for the home visiting program: demographics, benchmarks, rate card, and OEC requirements.

The benchmark number in the first column corresponds to the benchmark number in the benchmark report. Please note that in some cases, the benchmark measure itself, modeled after the federal requirements, can be more limited than what the OEC requires. For example, breastfeeding information is collected at birth, 6 months and 12 months. The benchmark report only considers breastfeeding at 6 months. Another example concerns ASQ-SE's. The expectation for OEC home visiting is that home visitors will perform ASQ-SE's with their families. However ASQ-SE's are not included in the benchmark report. Since it can be confusing to know what is included (and what's not) in the measures in the benchmark report, see “Definitions of Measures in Benchmark Report” for the definitions of those measures.
