^{*}Demographic information includes: address and contact information, marital status, housing status, income and sources of income, health insurance, educational attainment, and educational and employment status.

- Income is especially important to update/verify at the end of the January March quarter, especially if income is entered as a poverty level range, since poverty level cut offs change slightly each year. The OEC will provide the yearly updated cut-off amounts.
- ➤ Health insurance, educational attainment, and educational status are especially important to update/verify at the end of July September quarter, since those form the basis of benchmarks 15 and 16. (The benchmarks are based on the federal fiscal year which runs October 1 through September 30).

The OEC home visiting program requires information to be collected throughout the course of a family's enrollment. This table shows the timing of the data collection as it lines up with a caregiver's enrollment and the reporting quarter. Other measures are aligned more with the child's age. The table that shows those measures is "Timing of Home Visiting Measures by Child's Age". Please use both tables together; together they cover the timing for all data collection for the home visiting program: demographics, benchmarks, rate card, and OEC requirements.

The benchmark number in the first column corresponds to the benchmark number in the benchmark report. Please note that in some cases, the benchmark measure itself, modeled after the federal requirements, can be more limited than what the OEC requires.
