<u>Early Start CT</u> is a new OEC-funded program that combines Child Day Care Contracts, School Readiness Grants, and State Head Start Supplement Grants — into 1 new program.


Governor Lamont set up a permanent savings account to fund early childhood education, that will grow over time.

This is the first important step to build a strong, sustainable child care system for the state.

There are milestones, rules, and an advisory board to guide how the funds are used.

The advisory board will be chaired by the OEC Commissioner, a House of Representatives member, and a Senate member.

Initial Investment

Starting in July 2025, the endowment will provide the first year of funding, up to \$36 million, to support the early child care system for Connecticut.

Early Start CT

OEC issues contracts with providers for early childhood spaces. More changes will follow to increase the number of spaces and programs. Provide funding to support the quality and financial health of the overall system, including more competitive compensation.

All Programs

Bond funding will help support facility construction and improvements. Access Health CT will conduct a study to understand health insurance needs and opportunities for early childhood workers.
