About Elevate

Elevate is Connecticut's system to provide free access to resources and expert information for ALL early care and education providers.

You Are Already a Part of Elevate! Congratulations! You are already considered an Elevate Member with full access to resources and support for your business, your team, and your future!

YOU ARE UNIQUE

As a Connecticut (CT) early care and education provider, you are unique. There is only one program that does exactly what you do. Like people, providers are individual and have strengths. Those differences allow our state to have a strong, diverse system of early care and education. Elevate works to ensure your unique difference as a provider is your strength, and you are supported in areas needed.

Families seeking child care will be able to view each provider's Elevate status on their 211 Child Care profile. This will assist families in finding providers that meet their needs.



Elevate Member Levels

Elevate providers fall into three levels:

MEMBER


Licensed child care provider*

MEMBER+

Licensed child care provider* taking steps to strengthen their program

MEMBER ACCREDITED

Meets national standards for early learning and education



While all CT licensed providers* are Elevate Members, some providers choose to engage consistently with resources, coaching, and support offered through the Elevate system. Those Members who wish to strengthen their unique abilities and submit a plan are considered Member+. Providers who reach accreditation are considered Member Accredited.

Members who wish to strengthen their area of expertise or improve something important to them may commit to a focus area. A focus area might be strengthening abilities in child development, team building for a strong staff, or partnering with parents to ensure they have the resources their children need.

To move from Member to Member+ status, providers must submit an Elevate Program Plan and have it approved. An important step to developing your Elevate Program Plan is choosing 1-3 SMART Goals within your focus areas.

Focus Areas

Elevate has 6 focus areas, and each is important to a successful child care program.

Any CT early care and education provider may choose one or more focus areas, and submit a plan to work with the OEC Elevate team to strengthen their abilities. That strength helps the provider advance at their unique business, and helps CT families and children to get even better early care and education.

What is a SMART goal?

SMART goals are specific, measurable, attainable, relevant, and time-bound.

Explore Accreditation

Becoming accredited means achieving national distinction as a high quality program. Those who have achieved Member+ status can use the work they have done as the first steps towards being accredited. In fact, the Elevate Program Plan can serve as a key deliverable in the accreditation process!

Accreditation: Steps to Get Started

- 1. Identify your national accrediting organization
- 2. Connect with key resources

Identify your national organization

For center and group homes care: NAEYC (National Association for the Education of Young Children)

For family child care:

NAFCC (National Association for Family Child Care)

Head Start programs are also considered approved or "accredited" and are Member Accredited in Elevate. Head Start programs are administered by the Office of Head Start (OHS).

Connect with key resources

Get help from a Service Navigator:

Our Service Navigators are experienced guides who can talk with you about your goals and resources within Elevate focus areas to help you meet your plan.

Accreditation Quality Improvement Supports (AQIS):

AQIS offers free professional development to providers; includes study groups on selected NAEYC accreditation standards; and best practices in early care and education.

AQIS supports providers using the framework of NAEYC Accreditation to help providers reach the Member Accredited level.

Staffed Family Child Care Networks (SFCCNs):

SFCCNs support family child care providers with accreditation readiness, training, networking, and access to nurse consultants.
