2/24/25	There are a number of required attachments for the LGP Intermediary proposals, specifically the three years of audited financial statements, which will be possibly 75 pages for all three years. Would you rather the larger attachments be separated from the main proposal and labeled for each type of attachment? or combine some of the attachments of different types up to the 25MB size limit and label them as attachments part 1, for example? If the required attachments make the proposal larger than 25MB, are we allowed to send it as two emails? Thank you for your guidance on this matter.	<ul style="list-style-type: none"> <li>The larger attachments that are not part of the main proposal can be labeled accordingly and attached in the same e-mail. If the required attachments make the proposal larger than 25MB, you may send the attachments as two e-mails as long as both are submitted in their entirety by the deadline of 5:00 pm.</li> </ul>
2/28/25	The RFP states The LGP Intermediary ("Intermediary") will directly subcontract with and manage 50-70 newly established Local Governance Partners (LGP). Is it the responsibility, under this RFP for the Intermediary to recruit the LGPs?	<ul style="list-style-type: none"> <li>Per page 15-16 of the RFP, the Intermediary will have the responsibility of ensuring that newly established LGPs are formed and trained.</li> </ul>
2/28/25	What is the time frame to execute the subcontracts to LGPs? Do you expect the 50-70 LGPs to be executed in the beginning of the contract period (7/1/2025)?	<ul style="list-style-type: none"> <li>OEC will work with the selected vendor to ensure the LGP subcontracts are executed in a timely manner.</li> </ul>
2/28/25	Will the LGPs have a year to spend out their subcontract funds? Should subcontract funds be expensed by 6/30/2026 of year 1 and 6/30/2027 for year 2?	<ul style="list-style-type: none"> <li>Per page 6 of the RFP, subcontracts shall be for 2 years.</li> </ul>
2/28/25	How much of the funding will be available at execution? Can the negotiations include a time frame for fund disbursement?	<ul style="list-style-type: none"> <li>OEC will discuss payment structure with the selected vendor to ensure successful implementation of the contract.</li> </ul>
2/28/25	Is there potential for additional years of funding after the 2 year project period?	<ul style="list-style-type: none"> <li>The possibility of a contract extension will be discussed with the selected vendor.</li> </ul>
2/28/25	Where in the application should the List of Board of director be included?	<ul style="list-style-type: none"> <li>Per page 27 of the RFP, this shall be part of the Budget and Staffing Plan response.</li> </ul>
