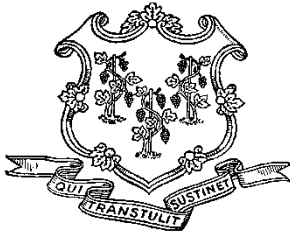

The contract between United Way of Connecticut, Inc. (*the "Contractor"*) and the Office of Early Childhood (*the "Agency"*), which was last executed by the parties on effective date: 7/1/2015, is hereby amended as follows:

1. Effective July 1, 2015, the Contracting State Agency is changed from the Department of Developmental Services to the Office of Early Childhood pursuant to Public Acts 14-39 and 15-5, and all references to "Department" or "Department of Developmental Services" in the original contract and its subsequent amendments shall henceforth refer to the Office of Early Childhood.
2. Part 1 Section L.3 on page 5 of the contract is amended to increase the total maximum amount payable under this contract by \$17,500.00 from \$1,576,500.00 to \$1,594,000.00. The increase amount shall be used during FY17 to expand current tasks relating to the Birth to Three Services website, including a redesign of the website as described in Part I, Section G of the contract.
3. Part I, Section L.3 of the contract is hereby amended as follows:  
The total amount of this contract shall not exceed \$300,000 for FY16, \$325,000 for FY17, \$315,000 for FY18, \$323,000 for FY19, and \$331,000 for FY20 under this contract or \$1,594,000 total in all fiscal years.
4. The second quarter payment listed in the budget in Part I, Section M of the contract is hereby amended as follows:  
Fiscal Year 2017  
10/1/2016            2<sup>nd</sup> Qtr Payment up to \$90,250 for services
5. All terms and conditions of the original Contract, and any subsequent amendments thereto, which were not modified by this Amendment remain in full force and effect.




