The contract between Cheshire Public Schools (*the "Contractor"*) and the Department of Developmental Services (*the "Agency"*), which was originally executed by the parties on effective date: 7/1/12, is hereby amended as follows:

1. Effective July 1, 2015, the Contracting State Agency is changed from the Department of Developmental Services to the Office of Early Childhood pursuant to Public Acts 14-39 and 15-5, and all references to "Department" or "Department of Developmental Services" in the original contract and its subsequent amendments shall henceforth refer to the Office of Early Childhood.
2. Page 1 of the contract is amended because the total maximum amount payable under this contract has increased by \$412,000.00 from \$1,500,000.00 to \$1,912,000.00 to fund services through 6/30/18.
3. The contract is extended by one year and the contract end date is changed from 6/30/17 to 6/30/18.
4. Part I, Sections 1.a and 1.b of this contract are hereby deleted and the following is substituted in lieu thereof:
  - a. **Population:** This contract is for the operation of an General, comprehensive Birth to Three Program serving all eligible children also known as "Clients" as defined in Part II, Section A.5.
  - b. **Duration:** The Contractor agrees to operate one or more Birth to Three Programs ("Program") for eligible children, under the federal Individuals with Disabilities Education Act ("IDEA")(34 CFR Part 303) and its regulations, C.G.S. § 17a-248 and its regulations, and Birth to Three procedures and service guidelines issued by the Department, as such statute, regulations, procedures, and guidelines may be amended from time to time, for the term of this contract. This contract may be renewed up to an additional 5 years. Any renewal of this contract shall require an amendment executed by the parties and approved as to form by the Office of the Attorney General.
5. All terms and conditions of the original Contract, and any subsequent amendments thereto, which were not modified by this Amendment remain in full force and effect.


