The contract between **Triple P America, Inc.** (*the "Contractor"*) and the **Office of Early Childhood** (*the "Agency"*), which was last executed by the parties on effective date: 10/28/13 and previously amended on 8/14/14, 3/12/15, and 10/9/15, is hereby further amended as follows:

1. Page 1 and Part I, Section E of the contract are amended because the total maximum amount payable under this contract has increased by \$95,000.00 from \$380,000.00 to \$475,000.00 to fund services as amended herein through 6/30/2017.
2. The term of the contract is extended for an additional year and the end date of the contract is changed from 6/30/2016 to 6/30/2017.
3. The following subsection shall be appended to the Triple P Training section in Part I, Section D.3 on page 4 of the original contract, as amended in item 3 on page 1 of Amendment 1:
  - i. During the period 7/1/2015 through 6/30/2017, the Contractor will provide three (3) Triple P training sessions to approximately 60 participants in the following manner:

Item	Cost
Two Primary Care trainings	\$51,840
2 Primary Care pre-accreditation days	\$ 7,260
One Selected Seminar training	\$12,605
Tip sheets and parent workbooks	\$23,295

4. All terms and conditions of the original Contract, and any subsequent amendments thereto, which were not modified by this Amendment remain in full force and effect.






