

## **Program Open/Closed Status**

- The total number of available child care slots the week of 10/27 was an estimated 87,647 or 64.6% of the pre-COVID total.
  - This represents a 3.4% increase in available child care slots since 10/7.
- There was an increase in the number of open child care centers. 40 new programs opened in October, increasing the number of open centers from 899 to 939 (68.2% of all licensed). The number of family child care homes open increased by 10. As a result, 1,476 homes (78.5% of licensed) are open.
- Expired licenses since March: 2 FGH dropped license (2%), 52 Centers (4%), 102 FCC Homes (5%). 83 FCC licenses issued in same period.

Survey was fielded **9/2/20 – 9/21/20**. It was advertised through Facebook, child care providers, and ECE listerv.


3.917 families responded;

representing **1.925 preschoolers** and **1.527 infants and toddlers**.






### Changes in Child Care Arrangements Before COVID & During COVID





## Grants

### **CT CARES Small Business Grant Program through DECD**

- Department of Economic and Community Development \$50 million grant program to help Connecticut small businesses and non-profits during COVID-19.
- Child care business may be eligible for a \$5,000 grant that you can receive before the end of the year. Online application will be available the week of November 9. Information sessions available.

## CCCCB: WBDC (Women's Business Development Council)

- Application is open for emergency operating funds from the Governor's Workforce Council (\$875,000 to be awarded; application closes 12-10-2020)
- 262 programs have applied as of 10-28-2020

- WBDC will help providers to create business documents if they do not already have them
- English and Spanish application, and live bilingual support
- Programs that do not qualify or are not awarded will still be offered support from WBDC under the original OEC contract

## Governor's Emergency Educational Relief (GEER)

## What is it ?

- Funding for GEER comes from \$3 billion dollars Congress set aside for the Education Stabilization Fund through the CARES Act.
- CT received \$27.8 million dollars, of which OEC received \$4 million dollars

## Who are we reaching?

 Intended to offer equitable resources to at risk (yet resilient) Connecticut families with young children who have limited access to remote learning technology and resources.

### Specifically, GEER is reaching out to:


- Families with children with medical complexities
- Families with children where family member has comorbid medical condition
- Families with economic challenges (low income)

## **How is this Implemented?**

 OEC is Partnering with the Regional Educational Service Center Alliance (RESC), New England Assistive Technology (NEAT), and a Community Based Agency to help distribute iPads and provide technical support and learning for children and families.







## When does it end?

GEER Funds will be used from now until September 2021\*
...However, there is no end date regarding the return on investment
