Admin / Multi Site Administrative (MSA) access users log in and click on Program Administration on the left menu, then Program File Manager for individual sites. Instructions for uploading documents are available in the Submitting Documents tab on the home page. Remember that NAEYC portal screen shots must include the program name.
