9/6/2024	For organizations operating locations across multiple sites with different licensing numbers, how should the program address the requirements associated with each program? Additionally, is there a possibility of serving as an intermediary for a program that is license- exempt?	In your program proposal, please indicate how your proposal is in alignment with the requirements of each of your programs. An intermediary will need to follow the same eligibility requirements as Pathway A: apprentices are hired by OEC-licensed centers and group homes.
9/6/2024	If a recently hired individual has just begun the application process and registered with the council, are they eligible to be considered an apprentice? We have actively supported our staff in obtaining Child Development Associate (CDA) credentials; can those who have just begun this process also be counted as apprentices?	An apprentice is required to complete 2000 hours of on the job (OJT) training, and they need to complete the CDA credential before they are considered to have completed their apprenticeship. If they have started their CDA prep, they would still be able to register as an apprentice but would need to complete the 2000 OJT hours at the employer's site, as well as complete all necessary steps to obtain the CDA credential. 9/6/2024	Could the role of the program coordinator include acting as a mentor, or should those be kept separate? Alternatively, is it permissible for the program coordinator to also fulfill the role of conducting CDA evaluations and assessments?	These roles should be separate; however, as there is a 2:1 apprentice to mentor ratio, if the site hired two apprentices and the mentor was able to fulfill both the coordination role and the mentor role, that could be a possibility. Best practice is that the mentor is a seasoned classroom teacher, ideally in the same classroom as the apprentice. The program coordinator could fill the role of informal assessments; the CDA Council requires a professional development specialist (certified by the Council) to complete a formal site visit and assessment of the apprentice.

For example, would there be a start-up and recruitment cost added for an intermediary that would apply to train apprentices? For staffing costs, does that line item apply to programs and include the hiring of the apprentices, or does it also include cost for staffing at the intermediary agency?	This effort will likely involve paid staff. In either pathway, there should be no line item for the wages / benefits for the apprentice(s); that is the responsibility of the employer who hired the apprentice as a W2 employee.
9/6/2024	Can you explain the difference between path A and path b?	Pathway A is for employers who hire apprentices and sign an agreement between the CTDOL, the apprentice, and the employer that the employer intends to provide all of the necessary tools and resources in order for the apprentice to successfully complete their apprenticeship and, in this case, obtain their CDA credential. Pathway B is for intermediaries who wish to support the apprentice and the employer to successfully complete the above. Please see the glossary on pages 33-35 of the RFP for additional detail on each role.
9/6/2024	Will a recording of the OEC bidders conference be posted on the OEC website?	The RFP bidders conference was recorded and is posted along with a copy of the slide deck on the OEC website.
9/6/2024	What is the end date for RFP submissions?	RFPs must be submitted by no later than 5 pm ET on Friday, October 4 th , 2024.
9/6/2024	Can a program coordinator at a site also be a mentor for an apprentice?	Yes, a program coordinator can also be a mentor; however, best practice is that a mentor is a seasoned ECE professional in the same classroom as the apprentice.

There are stipends for mentoring included with the budget template and are intended as a bonus for the mentor. This funding opportunity is not intended to pay wages of either the apprentice or the mentor.
